



Show/Breeding Guarantee

*Applies *ONLY* to *SELECTED* Dogs of DAVEN's choice*

This animal is of show and breeding quality and is sold with the additional guarantee that it does not have any breed disqualifications or any major faults based on the standard for the breed and has at least the minimum breed characteristics necessary to compete for Championship points as set forth by the American Kennel Club and its rules, regulations and guidelines regarding conformation shows. It is understood that all dogs will have minor flaws.

If, with concerted effort (including but not limited to proper training and handling, including an evaluation by and use of a professional handler, if necessary) this dog is unable to obtain points towards its Championship, it will be replaced in accordance with the terms of the breeder's *10 YEAR LIMITED REPLACEMENT GUARANTEE*.

This animal is guaranteed to pass OFA Certification with at least a Fair reading.

The x-rays must be done no sooner than 24 and no later than 36 months of age.

If this animal does not pass OFA certification with a Fair or better reading by the age of 36 months, it will be replaced in accordance with the terms of the breeder's *10 YEAR LIMITED REPLACEMENT GUARANTEE*.

Should the puppy/dog be diagnosed with Hip Dysplasia or PRA before 5 years of age, which is attested to by two unassociated veterinarians, the SELLER will upon provision of veterinary reports and where applicable, Orthopedic Foundation for Animals (OFA) report, or Canine Eye Registration Foundation (CERF), provide the BUYER with one of the following options:

- Should the BUYER choose to keep the puppy/dog and accept a refund, the SELLER will refund 50% of the purchase price. The puppy/dog must be spayed or neutered at BUYER's veterinarian of choice. BUYER must provide spay/neuter certification from the veterinarian to the SELLER before a refund will be issued. Costs of spay/neuter is the responsibility of the BUYER.
- Should the BUYER choose to keep the puppy/dog and accept a replacement puppy/dog, of similar quality, the BUYER must pay 50% of the original puppy's/dog's purchase price and any shipping or miscellaneous charges associated with transport of replacement puppy/dog. The original puppy/dog must be spayed or neutered and spay/neuter certificate must be provided to the SELLER before a replacement will be made. The costs of spay/neuter is the responsibility of the BUYER. The SELLER will replace puppy/dog with another puppy/dog of equal quality as soon as such a puppy/dog becomes available.
- Should the BUYER choose to relinquish ownership of the puppy/dog to the SELLER, the SELLER will replace the puppy/dog with a puppy/dog of similar quality. The SELLER will provide a replacement puppy/dog as soon as such a puppy/dog is available to the SELLER. All shipping charges are the responsibility of the BUYER.

Hip placement is extremely important and directly correlated to the quality of the x-ray reading.

Show/Breeding Guarantee (Cont.)

DAVEN's maintains the right that if the animal does not pass with the first x-rays, and an OFA SPECIALIST has not been used, breeder maintains that an OFA specialist be consulted and that the animal be re-x-rayed by the specialist BEFORE replacement is made.

Puppy/dog shall not be bred until receiving certification from OFA on hips. Preliminary OFA evaluation will also be sufficient. All costs for OFA certification and/or preliminary evaluation are the responsibility of the BUYER. The BUYER will forward a copy of OFA certification to the SELLER upon receipt.

Puppy/dog shall be bred only to OFA certified males/females.

It is strongly recommended that an OFA preliminary evaluation be done at 6 months of age.

Stud Rights

If the puppy/dog is a male, the SELLER retains stud rights to the dog, for the life of the dog, irrelevant to who owns the dog. The SELLER has approval rights to any bitch bred to said dog. The stud rights are defined as "The SELLER shall have the right to breed any dog owned or co-owned by the SELLER to the said dog without a Stud Fee". Approval rights are defined as "The SELLER must approve of all bitches bred to said dog that are not solely owned by the BUYER.

By signing and dating this ADDITION TO THE CONTRACT & BILL OF SALE, Buyer/Owner acknowledges having read and agreed to uphold the terms of this * 10 YEAR LIMITED RELACEMENT GUARANTEE*.
